- **Update:** Jim Walker from UT on the Residential Parking Program. Jim notes that UT will not continue to pay for the RPP permits for Swede Hill residents after 2017. Additionally, the City of Austin is changing the way they administer the program and will require individuals to pay the City directly rather than through a neighborhood representative. We will keep you informed on the new procedures.
- **Action Item:** Residential Parking Program endorsement for Waller Street section. This application was endorsed by the members present.

- OCEAN update by Tracy Witte - See item above regarding CodeNEXT position paper.
- Central Health Update from Tracy Witte - Central Health officials have altered their proposal for the Brackenridge Campus redevelopment to request Central Business District (CBD) entitlements. Central Health officials perceive this

alteration to be a simpler proposition for the redevelopment. They propose to go to the various Boards and Commissions in July/August, and proceed to City Council in September.
